


Cannabis markets in the EU



Cannabis: Europe's most valuable drug market


Estimated minimum retail value of the illicit market for the main drugs in the EU





Note: Percentages do not add up to 100 % due to rounding. Source: EMCDDA.


Cannabis market share: EUR 9.3 billion



- •Key figures 2014
- •It is estimated that:
 - 22 million used it in the last year
 - About 3 million adults use it on a daily basis
 - About 640 tonnes each of herbal and resin consumed (2013)
 - 139 000 people entered treatment
 - 820 000 offences
 - 138 000 supply offences







Seizures

Seizures of cannabis reported in Europe, 2006-14


Herb: Number of seizures (thousands)




Resin: Number of seizures (thousands)

Resin: Quantities seized (tonnes)










Products and market innovation



Herb

- Intensive and sophisticated domestic production techniques and modus operandi
- Increased potency
- Licit commercial cannabis market (USA) and product innovations are likely to have knock-on impact for EU

Resin

- Imported mainly from Morocco
- Increased potency
- Some high potency resin made in Europe



Products and market innovation

YIELD and PROFITS of indoor cultivation sites


- Intensive and sophisticated domestic production techniques and modus operandi
- Belgian study (Vanhove et al., 2014) concluded that surface is more determining than number of plants for yield calculation
- Under 600W lamps and average 16 plants/m²: 575 grams per m² yield
- Financial gains (ROC Return on Costs) calculated between 2.8 6.8

ERICP

- Information gap:
 - EMCDDA has total number of dismantled sites in many (not all) countries
 - Need for other information on size, types, methods, etc.
- At national level also, ERICP should be helpful
- Exchange of information: ERICP makes it easier to exchange comparable information across countries




Trafficking flows of cannabis herb



- Key players: Dutch and ethnic Vietnamese organised crime groups
- Albanian-speaking OCGs and motorcycle gangs also active
- UK, Italy, Belgium, Netherlands: major producing countries
- 'Delocalisation' of production
- Violence



Trafficking flows of cannabis resin



- Key players: Moroccan organised crime groups
- Dutch and Albanian-speaking groups also active
- Netherlands: key distribution hub (Moroccan and Afghan)
- Afghan hash makes inroads (Albanian groups)
- Violence



Moroccan resin goes east









- Cannabis: very important in Rif region
- European market share shrinking
- Large amounts exported towards eastern Mediterranean
- For Europe? Middle East?
- Links with migrant smuggling?
- Who sponsors, who benefits?




Libya: between the Rif and the Bekaa

- Pressed from herbal cannabis
- High potency
- Easier to conceal
- In 2015: 335 seizures in Europe, mainly Greece and Turkey
- Western Balkans

- Butane hash oil
- 'home-made'
- May lead to 'in house' fires and explosions
- 'Dabbing'

Key issues

- Largest drug market in Europe
- Market dominated by domestic herbal product
- Rapid innovation in production
- Potency increases, prices remain stable
- Health concerns both on use and 'selfproduction'
- Organised crime plays a key role
- Moroccan resin moving east
